Well Testing Application Form

Objective: Promote regular testing of private wells to ensure safe drinking water and identify potential contamination concerns

1. ELIGIBILITY & INSTRUCTIONS

The Northeast Red Watershed District (NRWD) delivers programming with the partnership from multiple organizations. To be eligible for programming, you must **own or rent** land within the NRWD boundaries in the following Rural Municipalities: *Brokenhead, Lac du Bonnet, Reynolds, Springfield, St. Clements, Ste. Anne, or Taché.*

Eligible Tests: Bacterial testing (Total Coliform and E.Coli)

Program Instructions: Residents must submit this form to the NRWD to participate in this program. Once receiving a confirmation of registration, participants can pick up a water sample bottle from the NRWD and participating RM offices. Samples must be collected according to the provided guidelines and returned within the required timeframe. Completed samples are to be dropped off at the NRWD and participating RM offices. The NRWD will coordinate delivery to the laboratory for testing. The laboratory will be in contact if your sample result indicates that bacteria is present.

A limited number of tests are available at no cost to residents each year, after which residents may still participate, but will be responsible for enclosing a cheque with the standard testing fee of \$17.67 (including taxes).

Only those samples that are accompanied by completed forms will be accepted.

3. CONDITIONS

The Landowner shall:

1. Register with the Northeast Red Watershed District (NRWD) prior to participating in the Well Water Testing Program
2. Pick up approved water sample bottles and follow all provided instructions for proper sample collection
3. Water samples must be taken the same day as drop off. Drop your water sample off at the NRWD office or your participating RM Office prior to 10:00am along with your completed Chain of Custody form to ensure accurate laboratory analysis.
4. Not alter or tamper with samples in a way that may impact testing accuracy
5. Acknowledge that free testing is limited to the number of prepaid samples available through the program
 - a. Be responsible for the standard provincial testing fee once the annual allocation of prepaid samples has been reached
6. Indemnify and save harmless the Northeast Red Watershed District, their agents, engineers, servants, and/or employees from any liability which may result from this project.

The Northeast Red Watershed District shall:

1. Notify the landowner regarding the status of their application
2. Provide sample bottles and instructions for proper collection
3. Coordinate the collection and delivery of water samples to the laboratory for analysis
4. Cover the cost of testing for approved participants until the allocated number of prepaid samples has been reached
